### Statistics

**Arrests included:** 11 warrant arrests, 2 shopliftings, 4 public intoxication, 1 possession of brass knuckles, 2 concealed dirk or dagger, 3 domestic violence, 1 domestic violence/VOP, 1 battery, 1 possession of a controlled substance/VOP, 1 possession of a controlled substance/VOP/delay peace officer, 1, possession of drug paraphernalia/VOP, 1 VOP, 1 Ukiah City Code Violation.

**Officers investigated and took reports of:** 5 CPS cross reports, 2 APS reports, 3 towed vehicles, 2 thefts, 3 found property, 3 graffiti reports, 1 robbery, 1 missing person, 1 mental health detention, 3 traffic collisions, 1 hit and run traffic collision, 1 rape report, 1 fraud report.

The Patrol Division's average response time to in-progress calls was just over 4 minutes. The average response time to all calls was just under 11 minutes.

### Highlights for the Week

On March 22, at approximately 3:30pm, a UPD officer was dispatched to a report of a suspicious female looking into vehicles. Upon arrival, a UPD officer contact Antonia Gonzalez, a 24-year-old transient. A records check revealed Gonzalez had two misdemeanor warrants for her arrest. Gonzalez was taken into custody without incident and booked into county jail. 17-0840

On March 22, at approximately 5:42pm, a UPD officer was dispatched to Pacific Outfitters regarding a shoplifting that had just occurred. Upon arrival, the UPD officer was met by the reporting person who had followed the suspect to a nearby business. The reporting person advised the officer that the female had just left the store wearing a swimsuit that had not been paid for. The UPD officer contacted the suspect, identified as Randa Medrano a 35-year-old transient, and noticed she was wearing the swimsuit. The stolen merchandise was recovered and Medrano was cited in the field for shoplifting and provided a court appearance date. 17-0842

On March 22, at approximately 8:14pm, UPD officers were dispatched to the 700 block of Cindee Dr. regarding multiple suspicious subjects. Upon arrival, UPD officers located two males in the area. The first subject was identified as a 17-year-old male, was found to be in possession of a dirk or dagger. The second subject, identified as Carlos Magana a 19-year-old resident, was found to be in possession of brass knuckles. Both subjects were taken into custody without incident. The juvenile male was booked into juvenile hall. Magana was booked into county jail. 17-0844

On March 23, at approximately 9:19am, UPD officers responded to the 800 block of W. Church St. for a report of a domestic violence disturbance. Upon arrival, UPD officers contacted the female victim and the male suspect, later identified as Michael Higgins, a 47-year-old Ukiah resident. After interviewing all of the involved parties, it was determined at scene that Higgins had committed domestic battery. Higgins was taken into custody without incident and booked into county jail. 17-0848

On March 24, at approximately 8:17am, a UPD officer was dispatched to Lucky's Supermarket regarding a suspicious vehicle. Upon arrival, the UPD officer located the vehicle and contacted the occupant who was identified as Virginia Oconnor, a 47-year-old female Willits resident. A records check revealed that Oconnor had a misdemeanor warrant out of Lake County. Oconnor was issued a citation for the warrant and provided with a court appearance date. 17-0855

On March 24, at approximately 10:41am, a UPD officer was dispatched to CVS regarding transients camping in front of the business. Upon arrival, the UPD officer contacted Michael McGee, a 28-year-old transient. A records check revealed McGee was on county probation. The UPD officer located a hypodermic needle, containing methamphetamine, in McGee's possession. McGee was taken into custody without incident and booked into county jail for possession of a controlled substance and violation of probation. 17-0856

On March 24, at approximately 12:40pm, a UPD officer was dispatched to a report of a suspicious vehicle in the parking lot of JC Penny's. Upon arrival, the UPD officer located the vehicle and contacted Luis Villalobos, a 24-year-old Mendocino county resident. The UPD officer discovered Anguiano was also in possession of methamphetamine. Anguiano was booked into county jail. 17-0861

On March 25, at approximately 1:33am, a UPD officer was patrolling the area of Hospital Dr. when he noticed a 16-year-old male stumbling in the roadway. The UPD officer contacted the juvenile and determined he was showing signs of alcohol intoxication. The juvenile was taken into custody without incident and booked into Juvenile Hall. 17-0862

On March 25, at approximately 2:50pm, a UPD officer was dispatched to the 500 block of E. Perkins St. for a report of a Domestic Violence incident between a man and a woman. Upon arrival, the UPD officer contacted all of the involved parties. A records check of the male, Walter Vasant, a 32-year-old transient, revealed he was on county probation. While at scene it was determined that Walter Vasant was in violation of his probation and had committed Domestic Violence. Vasant was taken into custody and booked into county jail. 17-0863

On March 26, at approximately 2:35am, a UPD officer was conducting a security check at Alex Thomas Plaza. While conducting the security check the UPD officer noticed a female, later identified as Cherri Roberts, a 40-year-old transient, sitting near the restrooms with an open container of alcohol. On arrival, the UPD officer was met by a Home Depot Asset Protection employee who informed him that the male subject had exited the store with merchandise that had not been purchased. A records check revealed Lockett had a misdemeanor warrant for his arrest out of Alameda County and was on county probation. Lockett was taken into custody without incident and booked into county jail. 17-0885

On March 28, at approximately 11:36 hours, a UPD officer conducted a bicycle stop in the 100 block of Ford St. The UPD officer contacted the subject and identified him as Rafael Sisneroz, a 31-year-old Fremont resident. While on the stop, the UPD officer located a concealed knife in Sisneroz pocket. Sisneroz was taken into custody for having a concealed dirk or dagger and booked into county jail. 17-0887

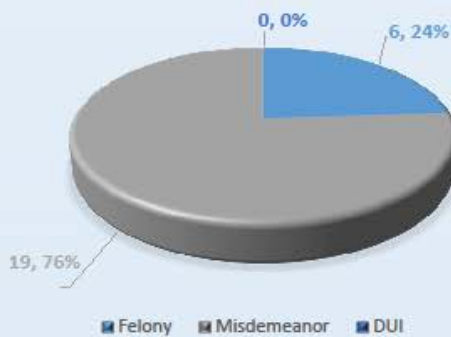

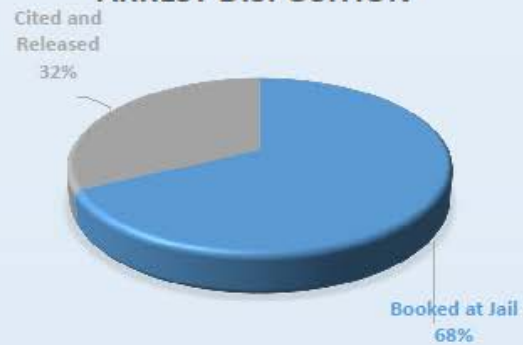

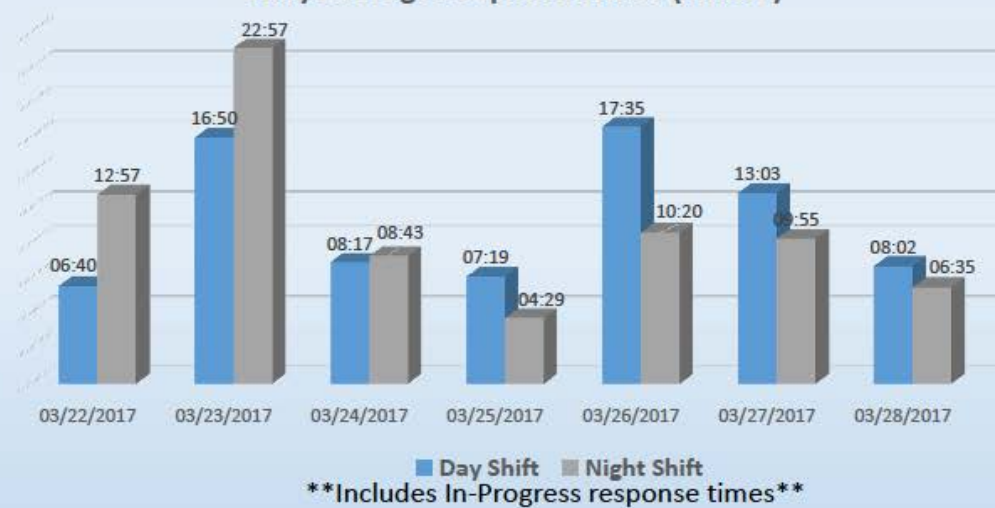
## CRIME BREAKDOWN
