Statistics

Arrests included: 11 warrants, 4 shopliftings, 3 drunk in public, 1 DUI, 1 drunk in public/VOP/warrant, 2 battery, 1 burglary/VOP, 1 VOP, 1 resisting or delaying a peace officer/VOP, 1 violation of a court order, 1 defrauding an inn keeper/VOP, 1 possession of methamphetamine, 1 possession of methamphetamine/possession of drug paraphernalia, 1 carrying a loaded firearm, 2 parole revocation, 1 reckless driver.

Officers investigated and took reports of: 4 CPS cross reports, 1 cat bite, 3 dog bites, 7 found property, 7 vandalisms, 1 theft, 1 stolen vehicle, 3 frauds, 4 vehicles towed, 3 missing persons, 2 mental health cases, 3 city code violations, 1 traffic collision, 1 forgery.

The Patrol Division's average response time to in-progress calls was just over 4 minutes. The average response time to all calls was just over 11 minutes.

Highlights for the Week

On March 29th, at approximately 8:16am, a UPD officer was patrolling the 600 block of Talmage Rd. The UPD officer recognized a vehicle parked in the Americas Best Value Inn parking lot. The UPD officer knew a male subject, identified as Andrew Martinez a 27 year old transient, was associated with the vehicle and that Martinez was currently wanted by Parole for a violation. The UPD officer contacted Martinez in the hotel room the vehicle was parked in front of. Martinez was taken into custody without incident and booked into county jail. 17-0894

On March 29th, at approximately 10:00am, UPD officers were dispatched to the 200 block of Brush St. regarding a verbal altercation. Upon arrival, UPD officers contacted Charlene Martinez, a 36 year old transient. Martinez advised a UPD officer that she had methamphetamine in her belongings. Upon arrival, the UPD officer contacted the male subject identified as Jordan Luna, a 26-year-old lake county resident. Luna was found to be intoxicated and taken into custody for public intoxication. Luna was booked into county jail. 17-0915

On March 30th, at approximately 8:35pm, a UPD officer responded to the area of 350 N. Orchard Ave. for a report of suspicious subjects. Upon arrival, the UPD officer contacted a group of transients in the area. A records check revealed one of the subjects, identified as Sean Moynahan a 31-year-old transient, had a warrant for his arrest. Moynahan was taken into custody without incident and booked into the county jail. 17-0916

On March 31th, at approximately 1:00am, a UPD officer was conducting a security check at Alex Thomas Plaza. The UPD officer located a female subject, identified as Cherri Roberts a 40 year old transient, sleeping in the park. Roberts was issued a citation for camping in the park and provided with a court appearance date. 17-0919

On April 2nd, at approximately 7:29pm, a UPD officer was dispatched to the 1000 block of S. State St. for a report of a male subject that had fallen from his bicycle onto the sidewalk. Upon arrival, the UPD officer located the subject laying on the sidewalk and identified him as Chris Huddleston, a 64-year-old transient. The UPD officer determined Huddleston was intoxicated and taken into custody for public intoxication. Huddleston was booked into county jail. 17-0948

On April 3rd, at approximately 1:31am, a UPD officer was conducting a security check in the 600 block of S. Orchard Ave. after receiving complaints of subjects camping in the area at night. The UPD officer contacted a sleeping subject in the area identified as Alicia Davis, a 25-year-old transient. A records check revealed that Davis had an out of state warrant. The UPD officer identified the subject as Cherri Roberts, a 40-year-old transient. Roberts was issued a citation for camping in the park and provided with a court appearance date. 17-0951

On April 3rd, at approximately 9:57am, a UPD officer was patrolling the 600 block of E. Perkins St. when he located a subject identified as Roger Schoenahl, a 45 year old transient. The UPD officer knew the subject to have an active warrant. The UPD officer contacted Schoenahl and took him into custody without incident. Schoenahl was booked into county jail. 17-0952

On April 3rd, at approximately 3:44pm, UPD officers were dispatched to a report of vandalism that had just occurred at 309 E. Perkins St. Upon arrival, UPD officers contacted the reporting party who provided a description of the suspect. A UPD officer located a male subject matching the description in the area, later identified as Richard Ortiz a 31-year-old Ukiah resident. A records check revealed Ortiz to have an active warrant and was on probation. While speaking with Ortiz, officers determined he was also intoxicated. After interviewing the reporting party and the suspect, it was determined that Ortiz had committed the vandalism. Ortiz was taken into custody for the warrant, violation of probation, public intoxication and vandalism. Ortiz was booked into county jail. 17-0961

On April 4th, at approximately 5:35am, a UPD officer was conducting a security check at Alex Thomas Plaza. The UPD officer located a female subject camping at the park. The UPD officer identified the subject as Cherri Roberts, a 40-year-old transient. Roberts was issued a citation for illegal camping and provided with a court appearance date. 17-0966

On April 4th, at approximately 8:33pm hours, UPD officers responded to Big 5 for a shoplifting that had just occurred. Upon arrival, a UPD officer contacted the reporting party who provided a description of the female shoplifter. Another UPD officer located the subject nearby who was identified as Vanessa Bartel a 23-year-old transient. A records check revealed that Bartel was on probation. The UPD officers found Bartel to be in possession of the property that was reported stolen. After speaking with the reporting party and Bartel, it was determined that Bartel had committed the theft and violated her probation. Bartel was booked into county jail. 17-0977
