Arrests included: 14 warrants, 2 warrants/concealed dirk or dagger, 1 warrant/public intoxication, 3 public intoxication, 1 public intoxication/resist or delay a peace officer, 2 DUI, 1 driving without a license, 1 driving without a license/possession of methamphetamine, 1 possession of methamphetamine/possession of drug paraphernalia, 1 shoplifting, 1 possession of a dirk or dagger/VOP, 1 Assault, 1 occupied stolen vehicle, 1 possession of drug paraphernalia/VOP.

Officers investigated and took reports of: 6 City of Ukiah Code Violations, 6 vehicles towed, 3 thefts, 4 found property, 2 traffic collisions, 1 mental health, 2 CPS cross reports

The Patrol Division's average response time to in-progress calls was just over 3 minutes. The average response time to all calls was just over 8 minutes.

Highlights for the Week

On April 5th, at approximately 10:38am, at UPD officer was patrolling the 100 block of Observatory Ave. The officer saw a male subject he recognized as Javier Ramirez, a 25-year-old Mendocino County resident, walking in the area. The UPD officer knew Ramirez to have a Mendocino County warrant and stopped to advise Ramirez about the warrant. The UPD officer took Ramirez into custody without incident. Ramirez was also found to be in possession of a dirk or dagger. Ramirez was then booked into county jail. 17-0981

On April 5th, at approximately 1:19pm, a UPD officer responded to the 300 block of Talmage Rd. regarding a female subject causing a disturbance. The UPD officer arrived at scene and contacted a male subject identified as Junqing Lu, a 20-year-old transient. A records check revealed Lu had a Mendocino County warrant. Lu was taken into custody without incident. Lu was also found to be in possession of a dirk or dagger. Lu was booked into county jail for the warrant and possession of the dirk or dagger. 17-0999

On April 7th, at approximately 1:02am, a UPD officer contacted two suspicious subjects in a vehicle in the 200 block of Ford st. The UPD officer was aware of a probation order of arrest for Fischer. The UPD officer contacted Fischer and advised him of the probation order of arrest. The UPD officer identified the three subjects as Joseph Shadowwolf, a 52 year old transient, Cheri Roberts, a 40 year old transient, and William Holt, a 51 year old transient. 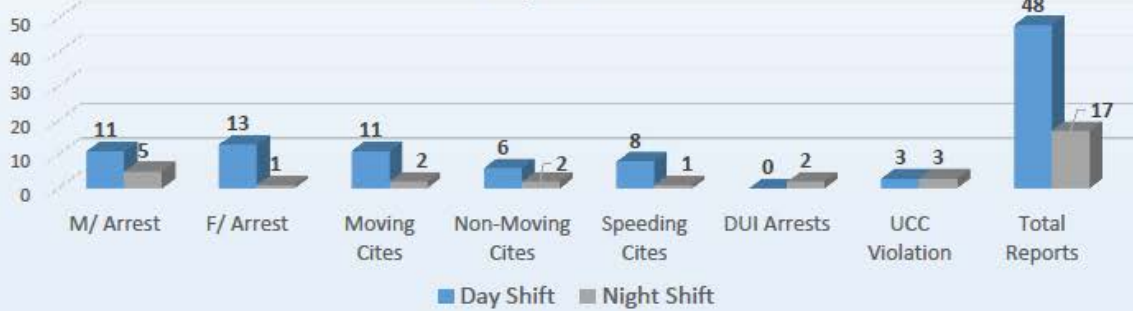

On April 11th, at approximately 1:34pm, a UPD officer conducted a traffic enforcement stop on a black Honda sedan in the 2100 block of S. State St. The driver was identified as Rolando Ruiz, a 28 year old Mendocino county resident. A records check revealed Ruiz had a San Mateo County warrant for his arrest. Ruiz was taken into custody without incident and booked into county jail. 17-1040

On April 11th, at approximately 3:49pm, UPD officers were dispatched to JC Penny's regarding a male subject inside the location causing a disturbance. Upon arrival, the UPD officers located the male subject who was identified as Adam Emarine, a 34 year old transient. As officers spoke with Emarine, they suspected he was under the influence of illegal drugs and began evaluating him for this. Officers went to place Emarine under arrest for public intoxication and he began to resist the officers. Emarine was physically restrained and handcuffed. Emarine was booked into county jail for public intoxication and for resisting arrest. 17-1045

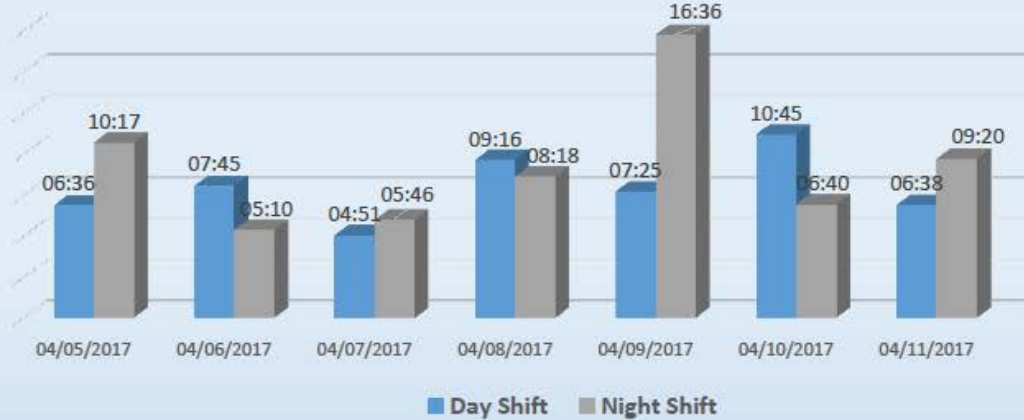
CRIME BREAKDOWN



ARREST DISPOSITION

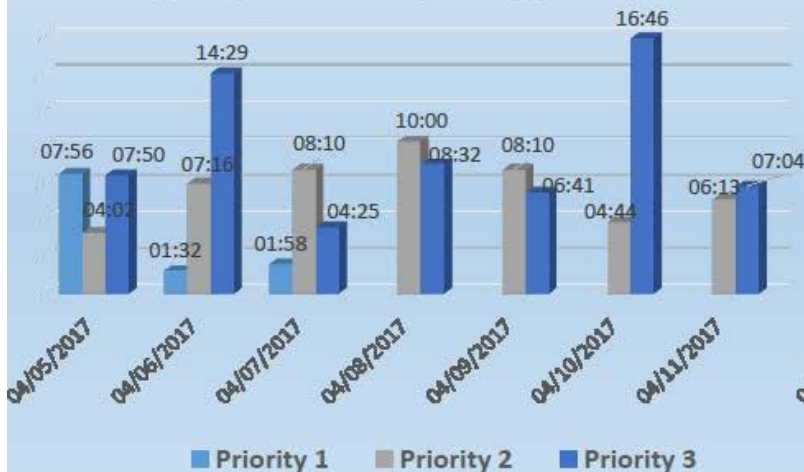


Daily Average Response Times (mm:ss)
