Arrests included: 5 public intoxications, 1 public intoxication/VOP, 6 warrant arrests, 1 warrant/VOP, 1 warrant/possession of methamphetamine/possession of drug paraphernalia, 1 possession of methamphetamine/possession of drug paraphernalia/VOP, 1 possession of methamphetamine/possession of drug paraphernalia, 1 possession of drug paraphernalia, 2 possession of methamphetamine, 3 DUI, 1 under the influence of a controlled substance, 1 under the influence of a controlled substance/false ID to a peace officer, 1 battery, 1 domestic battery/VOP, 1 assault, 1 trespassing, 1 theft of vehicle/unlicensed driver, 1 VOP.

Officers investigated and took reports of: 4 traffic collisions, 10 found properties, 3 vehicles towed, 2 vandalisms, 1 hit and run, 1 fraud, 1 burglary, 1 CPS cross report, 1 theft, 1 missing person, 1 drug registrant.

The Patrol Division's average response time to in-progress calls was just over 3 minutes. The average response time to all calls was just over 9 minutes.

On April 20th, at approximately 11:58am, a UPD officer responded to the 200 block of Clara Ave. regarding a female subject pushing a shopping cart into vehicles. The UPD officer located the subject, identified as Deborah Lawrence, a 50 year old transient. A records check revealed Lawrence had a warrant for her arrest and was on probation. The UPD officer noticed Lawrence was displaying symptoms of being under the influence of a controlled substance. Lawrence was taken into custody for the warrant, violation of probation, and being under the influence of a controlled substance. Lawrence was booked into county jail. 17-1132

On April 21st, at approximately 4:09pm, a UPD officer responded to the 300 block of E. Gobbi St. regarding a male subject laying in the parking lot. The UPD officers located the vehicle and contacted the occupants. The driver was identified as Owen Porter, a 28 year old Ukiah resident. A records check revealed Owens was on probation. Press Release: Shooting 800 block Cindee Drive Ukiah Police Department case # 17-1148

On April 22nd at about 11:48 am, a UPD Community Service Officer was dispatched to the 800 block of South Orchard Avenue, regarding a traffic accident. While working the traffic accident, he heard 4 to 5 gun shots very near-by and radioed UPD dispatch for assistance. On Cindee near the intersection of South Orchard Avenue, UPD officers located a 38-year-old male in the street. The male was suffering from multiple gunshot wounds and evidence was located indicating that he had been shot in the street. Officers rendered first-aid and the male was transported via ground ambulance to an awaiting air ambulance. The male subject was airlifted to a major trauma center out of county. UPD Detectives responded and investigated the shooting. The Ukiah Police Department is looking into whether the incident was gang related. If anyone knows of video surveillance in the area or has information regarding this incident, please contact the Ukiah Police Department Detective Division at 463-6262.

Press Release: Hit and Run / fire hydrant damaged Ukiah Police Department case # 17-1149

On April 22nd at about 4:18 pm, UPD officers were dispatched to the 400 block of Park Blvd., regarding a hit and run traffic collision. Upon arrival, officers located a white 2001 Mercedes coupe that had collided with a City of Ukiah fire hydrant. The Mercedes had been abandoned by the driver and had sustained major damage. The water main to the fire hydrant was broken, causing damage to the road and flooding in a nearby residence. City of Ukiah Public Works responded and was able to shut the water off. 


