### **Statistics**

**Arrests included:** 10 public intoxication, 1 public intoxication/VOP, 7 warrants, 1 warrant/possession of methamphetamine, 4 shopliftings, 2 DUI, 1 vandalism, 1 possession of methamphetamine/possession of controlled substance/VOP, 1 possession of a billy club/felon in possession of ammunition/felon in possession of a firearm, 1 battery.

**Officers investigated and took reports of:** 8 found property, 4 mental health cases, 3 traffic collisions, 3 burglary's, 2 fraud cases, 1 stolen vehicle, 1 theft.

The Patrol Division's average response time to in-progress calls was just over 5 minutes. The average response time to all calls was just over 8 minutes.

### **Highlights for the Week**

#### **Press Release / Possible attempt child abduction UPD case #17-1190**

On April 26<sup>th</sup> at about 10:42 am, UPD's School Resource Officer was dispatched to Pomolita Middle School, regarding a possible attempted abduction. Upon arrival, the 12-year-old female student reported that about 10 minutes earlier, she was walking in the 600 block of Dora Avenue, headed home from school. The student saw a white van parked on the street and as she passed, the driver of the van asked her to get inside. The student refused and continued to walk toward home, while ignoring the driver of the van. As she did the driver of the van began to follow her, while he kept trying to convince her to get into the van. The student ran to school and contacted staff, who immediately began investigating the incident. The subject was described as a white male adult, 30s to 40s, with a full beard and dark hair, wearing dark sunglasses and a dark leather jacket. The vehicle was described as a white panel van, with a broken rear tail-light and porcelain dolls on the front passenger seat.

The case was turned over to the Ukiah Police Department Detective Division. The Ukiah Police Department searched the area for the van with negative results. As a precaution, we also provided proactive patrols at local schools, as students were dismissed for the day. If anyone has any information regarding the above incident, please contact the Ukiah Police Department Detective Division at 463-6262.

The Ukiah Police Department is currently investigating the incident and working closely with the Ukiah Unified School District.

On April 27<sup>th</sup>, at approximately 1:35am, a UPD officer conducted an enforcement stop on a white SUV in the 400 block of N. Dora St. The officer contacted the driver of the vehicle, who was identified as Lane Nelson, an 18 year old county resident. As the officer spoke with Nelson, he suspected that Nelson was intoxicated and began a DUI investigation. A records check revealed that Nelson did not have a driver's license. Nelson was placed under arrest for DUI and for being an unlicensed driver. Nelson was booked, cited, and released from UPD. 17-1197

On April 27<sup>th</sup>, at approximately 1:35am, a UPD officer was assisting another officer on a traffic stop when he contacted a male subject identified as Vance Madson, a 19 year old transient. While speaking with Madson the officer noticed Madson was displaying signs and symptoms of alcohol intoxication. A records check revealed that Madson was on county probation. Madson was taken into custody without incident for public intoxication and violation of probation. Madson was booked into county jail. 17-1198

On April 27<sup>th</sup>, at approximately 8:31pm, a UPD officer was dispatched to the 400 block of N. Barnes St. regarding a male subject causing a disturbance in the street. On arrival, the officer located the male subject, identified as Joe Stra, a 45 year old transient. The officer noticed Stra was displaying signs of alcohol intoxication. Stra was placed under arrest for public intoxication and booked into county jail. 17-1207

On April 28<sup>th</sup>, at approximately 3:28am, a UPD officer was conducting a security check at Alex Thomas Plaza. The officer located subjects camping in the park and contacted them. A records check revealed one of the subjects, identified as Kayla Woltmon, a 28 year old transient, had a warrant for her arrest from Colusa County. Woltmon was taken into custody and booked into county jail. 17-1208

On April 28<sup>th</sup>, at approximately 12:19pm, a UPD officer was dispatched to Wal-Mart for a report of a shoplifting that had just occurred. On arrival, the UPD officer located the suspect, identified as Stephanie Milberger, a 25 year old transient. Milberger was placed under arrest for the shoplifting. Milberger was booked and released. 17-1211

On April 29<sup>th</sup>, at approximately 1:21am, a UPD officer was patrolling the 200 block of S. Orchard Ave. when he recognized a subject he knew to have outstanding warrants for his arrest. The officer contacted the subject, identified as Able Aguado, a 32 year old transient. The officer advised Aguado of the warrants and took him into custody without incident. ## Press Release / A report of a male attempting to lure a child - arrest of Parolee UPD case #17-1223

On April 29<sup>th</sup> at about 2:46 pm, UPD officers were dispatched to the 800 block of North Bush Street, for a report a male adult who had attempted to lure a minor child. While in-route, UPD dispatch advised responding officers that the subject was leaving the area on foot wearing a camouflage shirt, with a witness following him. Upon arrival an officer located the subject walking eastbound along Orr Creek, with a dog. The male subject verbally identified himself as "Michael Craft age 38", but was later identified as Shawn Lane, a 27-year-old parolee.

During the subsequent investigation officers spoke with the 7-year-old female victim and her mother. The 7-year-old was visibly shaken and had recently been crying. The mother reported that she was parked near the rear of the Bottle Shop Deli and her 7-year-old daughter walked to a nearby trash can. The mother was dealing with other children in her vehicle, when her daughter ran to her extremely upset. The daughter told her mother that a male subject near the garbage can had attempted to lure her with candy. The daughter was interviewed about the incident, during which told officers that she had attended a stranger danger class and knew not to talk with the subject, but to run and contact her mother.

The daughter described the adult male as having a red beard, red hair, wearing makeup around his eyes and an "Army" type shirt.

Officers were able identify Lane as the suspect in this case and he was placed under arrest for annoying a child under 18, false ID to a police officer, and for violating his patrol. The case was turned over to the Ukiah Police Department Detective Division, who is investigating if Lane has any connection with UPD case 17-1190, an attempted abduction case last week.

## **Press Release: Contact turns into arrest of subject with loaded handgun**

**Ukiah Police Department case # 17-1237**

On May 1<sup>st</sup> at about 9:37 am, UPD officers contacted a male subject in the 600 block of South Orchard Avenue. The subject identified himself as Brett Michael Adame age 25, a transient out of Florissant Missouri. While talking with Adame the officer asked Adame if he had any weapons on his person. Adame told the officer he had a pry bar concealed in his waistband. For officer safety an officer conducted a pat search of Adame for weapons. Adame was found not only to have this pry bar, but had a loaded 45 caliber semiauto handgun. The handgun was rendered safe and Adame was detained, while officers continued their investigation. A records check of the firearm revealed that it had been stolen out of Florissant Missouri. Adame's criminal history was reviewed and he was found to have prior felony convictions. Adame was placed under arrest for felon in possession of a firearm, felon in possession of ammunition, and possession of a billy club, then booked into county jail.








### CRIME BREAKDOWN
