### **Statistics**

**Arrests included:** 8 public intoxications, 7 warrant arrests, 3 shopliftings, 3 VOP, 3 domestic violence, 2 battery, 1 unlawful possession of Inhalant, 1 possession of a dirk or dagger/possession of methamphetamine/VOP, 1 possession of a controlled substance, 2 possession of methamphetamine/possession of drug paraphernalia, 1 vandalism.

**Officers investigated and took reports of:** 7 found properties, 6 City Code violations, 6 vandalisms, 4 traffic collisions, 4 towed vehicles, 2 thefts, 4 CPS/APS Cross reports, 2 mental health evaluations, 1 fraud report, 2 stolen vehicles, 1 burglary.

The Patrol Division's average response time to in-progress calls was just over 3 minutes. The average response time to all calls was just over 8 minutes.

### **Highlights for the Week**

On May 17<sup>th</sup>, at approximately 8:59am, a UPD officer responded to the 100 block of Ford St. regarding an intoxicated male subject in a vehicle in the area. Upon arrival, the officer located a male subject identified as William Long, a 54 year old transient. The officer observed Long displaying signs and symptoms of alcohol intoxication. Long was placed under arrest for public intoxication and booked into county jail. 17-1404

On May 17<sup>th</sup>, at approximately 2:29pm, a UPD officer was patrolling the 600 block of Leslie St. when he located a subject identified as Maria Marfil, a 36 year old transient. The officer was aware of several warrants for Marfil's arrest. The UPD officer contacted Marfil and took her into custody without incident. Marfil was booked into county jail. 17-1411




### CRIME BREAKDOWN
