### Statistics

**Arrests included:** 8 warrant arrests, 8 public intoxication arrests, 5 VOP, 1 VOP/UCC Violation, 2 shopliftings, 2 resisting or delaying a peace officer, 1 rape, 1 under the influence of a controlled substance, 1 battery/vandalism/VOP, 1 domestic violence/assault with a deadly weapon, 1 attempted robbery, 1 threats/battery/resist or delay a peace officer/ possession of drug paraphernalia/warrant arrest.

**Officers investigated and took reports of:** 6 found property, 6 cross reports, 3 vandalisms, 3 traffic collisions, 1 burglary, 2 thefts, 2 vehicles towed, 1 dog bite report, 2 missing person cases, 1 death investigation, and 2 mental health cases.

The Patrol Division's average response time to in-progress calls was just over 4 minutes. The average response time to all calls was just over 8 minutes.

### Highlights for the Week

On May 25<sup>th</sup>, at approximately 8:58 am, a UPD officer was patrolling the 200 block of Brush St. due to an ongoing issue with a subject trespassing at a residence in the area. The officer was checking the exterior of the residence when he located the subject, identified as Kristine Tupper a 44 year old transient, trespassing and camping on the property. A records check revealed Tupper was on county probation. Tupper was placed under arrest for violation of probation, unlawful camping, and trespassing after eviction. Tupper was booked into county jail. 17-1488

On May 25<sup>th</sup>, at approximately 2:45pm, a UPD officer responded to Mendocino County Farm Supply for a report of a female subject who had just shoplifted clothing items from the location. Upon arrival, the officer spoke with the reporting person who provided a description of the suspect. The UPD officer located the female suspect, identified as Aleshia Dedrick a 34 year old transient, in the area. Dedrick was placed under arrest for the shoplifting and provided with a court appearance date. 17-1499

On May 26<sup>th</sup>, at approximately 3:27 am, a UPD officer was dispatched to the 300 block of Talmage Rd. for a report of a male subject laying on the sidewalk. Upon arrival, the UPD officer located the subject and identified him as David Gonzalez, a 21 year old transient. The officer observed Gonzalez displaying signs of alcohol intoxication. On May 27<sup>th</sup>, at approximately 1:51 pm, a UPD officer was patrolling the 1100 block of Airport Park Blvd. when he located a female subject he recognized as Jennifer Cram, a 33 year old transient. The officer conducted a records check on Cram and dispatch advised the officer of a warrant for Cram's arrest. The officer contacted Cram and advised her of the warrant. The officer issued Cram a citation and a court appearance date. 17-1518

On May 28<sup>th</sup>, at approximately 1:32 am, a UPD officer was dispatched to the 1300 block of S. Dora St. regarding a disturbance. Upon arrival, the officer located a male and female in the area. The female was identified as Tina Cornwall, a 23 year old transient. A records check revealed a warrant for Cornwall's arrest. Cornwall was taken into custody without incident and booked into county jail. 17-1525

On May 28<sup>th</sup>, at approximately 3:25 am, a UPD officer was patrolling the area 195 S. Orchard Ave. when he located a male subject who was in violation of a City Ordinance. The officer contacted the subject, identified as Sergio Gonzalez, a 40 year old transient. A records check revealed multiple warrants for Gonzalez's arrest. ### **Press Release** **Intruder detained by resident and arrested UPD case # 17-1535**

On May 29th at about 12:40 am, UPD officers were dispatched to a residence in the 1100 block of Elm Street, for a report of a male subject who had unlawfully entered the residence and was now being detained. Upon arrival, officers found a male adult holding down a male subject on the floor inside the residence. Officers detained the subject in handcuffs and placed him in a patrol car, so they could begin their investigation. The male subject was identified as Erick O'Donnell, a 27-year-old Ukiah resident. Soon after having O'Donnell sit in the back of a patrol car, he got up and attempted to flee while handcuffed. Officers quickly restrained O'Donnell and he was safely secured in the backseat of the car. During the subsequent investigation officers learned that the male resident was asleep in his bedroom, while his girlfriend was asleep in another bedroom. The male resident woke up to what he thought was his dog barking and found O'Donnell inside his room. The male resident had no idea who O'Donnell was or why O'Donnell was inside his residence. The male resident yelled at O'Donnell to get out of his house. As the resident got up to deal with O'Donnell and O'Donnell went toward the resident, who was able to wrestle the intruder to the floor. The resident's girlfriend awoke, saw what was happening and called the police. Luckily the residents were not harmed. O'Donnell was placed under arrest for unlawful entry into a residence, prowling and resisting arrest. O'Donnell was transported to Ukiah Valley Medical Center for a medical clearance. After exiting the patrol vehicle, O'Donnell attempted to flee again and had to be forced to the ground by officers, in order to restrain him. After being medically cleared, O'Donnell was booked into county jail.

As a reminder here are some home security tips:

- Always keep your exterior doors locked.
- Install and use a quality lockable security screen, if you want your door open why you are home.
- Never ignore a knock on the door.
- Secure all windows. If you intend on using a window open for ventilation when you're at home, use a locking mechanism that allows the window only to partially open, so no one can fit through.
- Trim hedges below the window level to eliminate hiding spots for criminals.
- Install outside motion security lighting and make sure it is in good working order.
- Don't allow strangers in your home!
- If something is suspicious notify your local police.




### CRIME BREAKDOWN



### ARREST DISPOSITION




### ARREST RESIDENTIAL DEMOGRAPHICS
