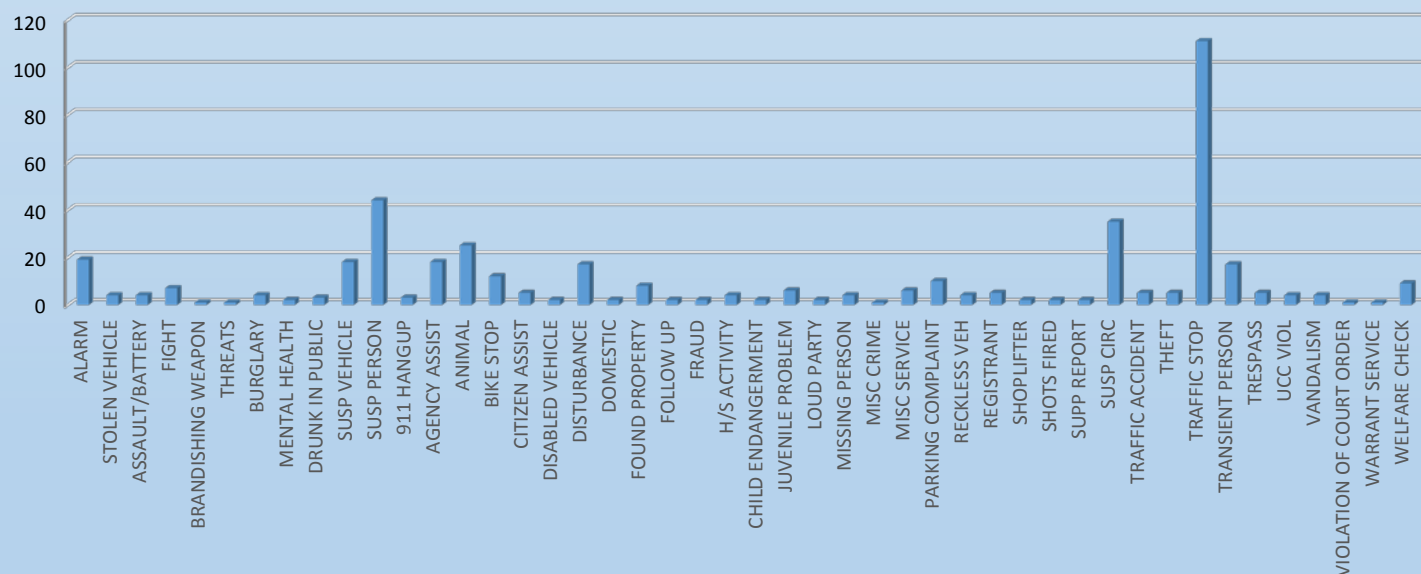

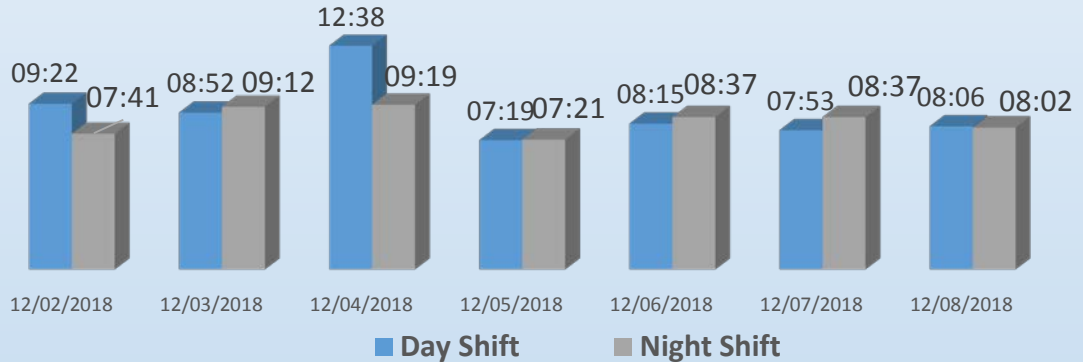

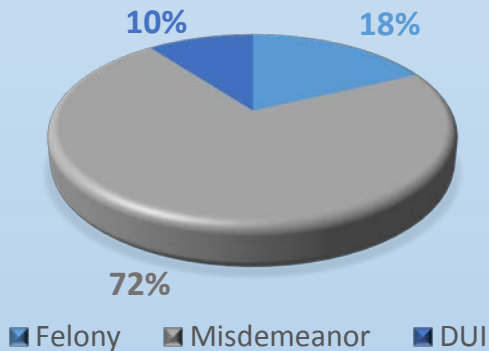
Daily Average Response Times (mm:ss)



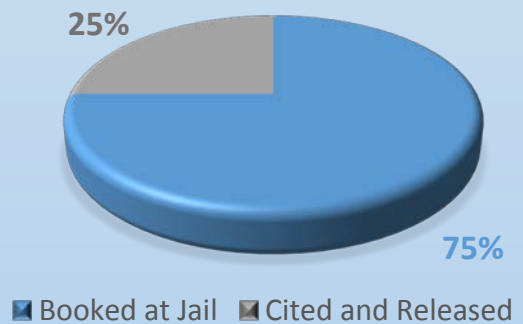
The Patrol Division's response time to in-progress calls was just over 4 minutes.

The average response time to all calls was just over 8 minutes.

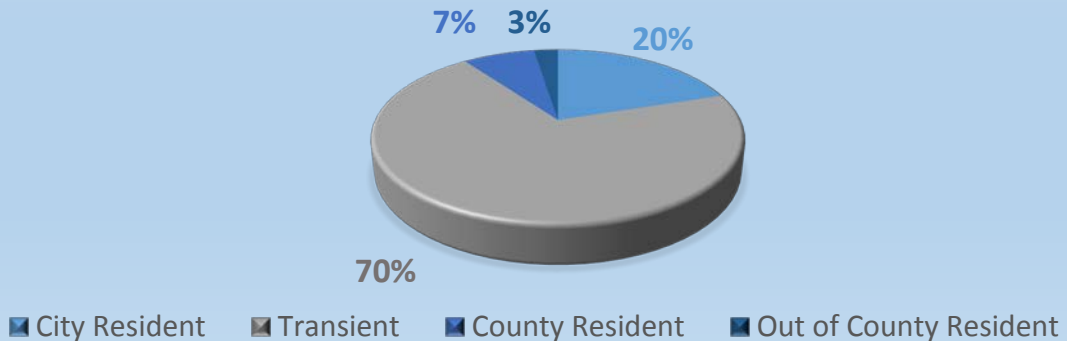
CRIME BREAKDOWN

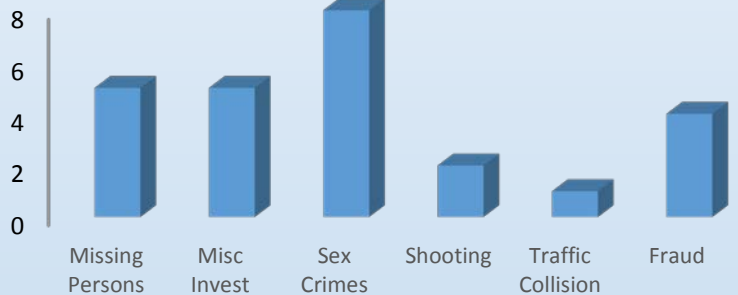

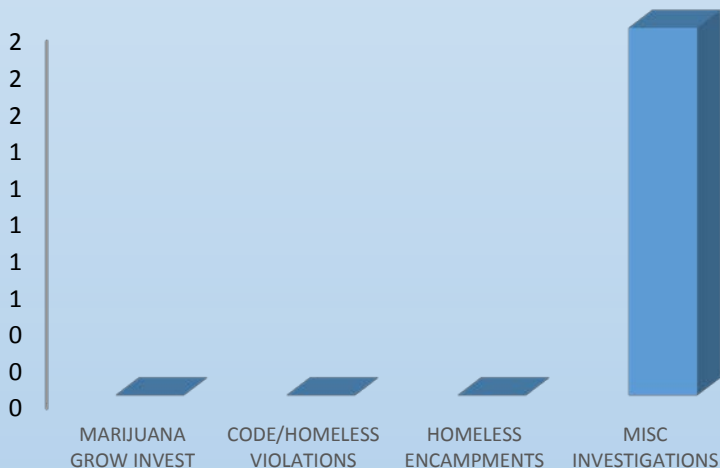

Bank Robbery UPD Case 18-1982

On 08/17/18, at 4:19 in the afternoon, UPD officers responded to the Chase bank in Ukiah for a robbery. Officers arrived to find the unknown suspect had fled. Officers learned that the suspect entered the bank passed a note demanding money. It also appeared the suspect had taken measures to conceal his identity. The suspect then fled the bank and was not located by responding officers. The case was forwarded to the Ukiah Police Department Detective Division.

Ukiah Police Detectives began working the case. Upon learning of subsequent similar bank robberies occurring in Sonoma County in the following months, Ukiah Police Detectives began working with Santa Rosa Police Department and Cloverdale Police Dept. in an attempt to identify the suspect.

On 12/04/18, Cloverdale Police responded to a bank hold up alarm at the Exchange Bank within their jurisdiction. The Cloverdale Police Department was able to stop the suspect as he fled the scene in a black Mercedes. The suspect, identified as Travis Strickland, was taken into custody. The Santa Rosa Police Department and Ukiah Police Department was notified of the incident and responded as well.

Ukiah Police Detectives assisted the Santa Rosa Police Department with processing the vehicle for evidence. The Santa Rosa Police Department secured search warrants for the vehicle and Strickland's residence, which was within the Ukiah city limits. Numerous items were located within the vehicle, connecting Strickland to multiple bank robberies occurring in Sonoma County, as well as the Chase bank robbery in Ukiah. Ukiah Police Detectives, along with Detectives from the Santa Rosa Police Department responded to Strickland's residence, where additional items of evidence were obtained.

Strickland was booked into the Sonoma County Jail by the Cloverdale Police Department for attempted robbery, robbery, burglary and an outstanding warrant out of Mendocino County.

Strickland's bail was set at \$500,000. The case for the Chase Bank robbery in Ukiah will be forwarded to the Mendocino County District Attorney's Office for prosecution.

Subway Robbery **UPD Case 18-1982**

On 12-12-18 at approx. 7:18 PM, UPD officers were dispatched to Subway (130 N. Orchard Ave.) regarding shots fired at the location. Upon arrival, an officer located a subject with gunshot wounds in front of Ross. The officer provided first aid until paramedics arrived. The subject was flown to an out of county hospital for medical treatment.

It was quickly reported that the injured subject had just robbed the Subway store with a firearm. During the robbery, a customer with a valid concealed carry weapons permit, discharged his firearm reportedly in fear of his safety and the safety of other citizens. The customer also was one of the reporting parties to the robbery. The investigation is on-going.
