


Daily Average Response Times (mm:ss)




The Patrol Division's response time to in-progress calls was just over --- minutes.

The average response time to all calls was just over --- minutes.


CRIME BREAKDOWN

ARREST RESIDENTIAL DEMOGRAPHICS









Press Release

Case 18-3264 and 18-3266

On 12-26-18 at approx. 6 AM, UPD officers were dispatched to the 100 block of Ford St. regarding a vehicle that had just been stolen. The vehicle (03 Honda Accord) had reportedly been left running and unattended to "warm up". UPD officers were provided a description of the vehicle and began searching the area. Approx. twenty minutes later, an officer observed a vehicle matching the description of the stolen vehicle in the South parking lot of Wal-Mart. The vehicle was parked in a handicap parking space with the trunk open (obscuring the license plate). Seth Smart (22 year old white male-Willits) was at the drivers door and appeared to be rummaging through the vehicle. Joshua Denney (38 year old white male-Laytonville) was standing on the passenger side of the vehicle. The vehicle was determined to be the stolen vehicle. It was quickly determined (via video surveillance) that Denney arrived in another vehicle and Smart arrived approx. 5 seconds after Denney and parked next to Denney. The two then appeared to rummage through the stolen vehicle.

Both Smart and Denney were arrested. Officers located a loaded pistol in the stolen vehicle on the drivers floorboard. Smart is prohibited from possessing firearms due to previous convictions. Smart was also found to have a meth pipe in one of his pockets. Denney had jewelry in his possession, which the victim later identified as belonging to her and had been left in the vehicle.

Smart was arrested for 10851(a) CVC (auto theft), 182(a)(1) PC (conspiracy), 29800(a)(1) PC (felon in possession of a firearm), 11364(a) HS (possession of drug paraphernalia). Denney was arrested for 182(a)(1) PC and 496(a) PC (possession of stolen property). The two were lodged at the county jail and the stolen vehicle was returned to the owner. Denney's bail was set at \$15,000 while Smart's was set at \$25,000.

At approx. 0832 hours (on 12-26-18), an officer was on routine patrol in the 100 block of Freitas Ave. The officer observed an occupied vehicle that was parked obstructing the sidewalk. The officer provided dispatch with the license plate and was advised the vehicle was a stolen vehicle. The occupant, William Pimentel (27 year old white male-Nice, Ca.), was arrested for 496(a) PC. Officers located suspected methamphetamine in the center console. Pimentel was additionally charged with 11377(a) HS (possession of a controlled substance). Pimentel was also lodged at the county jail.

Pimentel's bail was set at \$15,000. The stolen vehicle was a 2015 Dodge Challenger that had been stolen out of Lake County on Christmas day.

UPD would like to advise citizens not to leave their vehicles running and unattended. It is not uncommon for thieves to pair up and drive around to look for vehicles that are warming up to steal. The number of stolen vehicle cases tends to increase on colder nights. There have been numerous vehicles stolen recently while the owners were "warming up" their vehicles and left the vehicles unoccupied. Often times the stolen vehicles are used to commit other crimes. UPD Case 18- 3308

On 12-29-18 at approx. 10:30 PM UPD officers observed an off-road Yamaha dirt bike being ridden in the 1200 block of S. Dora St. in violation of multiple vehicle code violations. Officers attempted to initiate a traffic stop on the motorcyclist (Jordan Bright). Bright failed to yield to the emergency lights and siren and accelerated around another vehicle.

Bright had a passenger, ran numerous stop signs throughout the West side of Ukiah, and travelled at approx. 60 plus mph at times in the residential neighborhood. Bright drove into an industrial complex off of Feedlot Ln. and N. Bush St., where Bright was able to access a path where a patrol vehicle couldn't. During so, Bright's passenger (22 year old female) fell off of the motorcycle. Officers remained with the female passenger and requested EMS.

Bright continued to flee, leaving his passenger behind. Bright's passenger was transported to UVMC and later released. Bright was quickly apprehended after he crashed his motorcycle just South of Masonite Rd. in a vineyard. CHP and MCSO assisted with the pursuit and subsequent arrest. Bright was lodged at the county jail for recklessly evading, driving on a suspended license, and violation of probation for a prior DUI.
