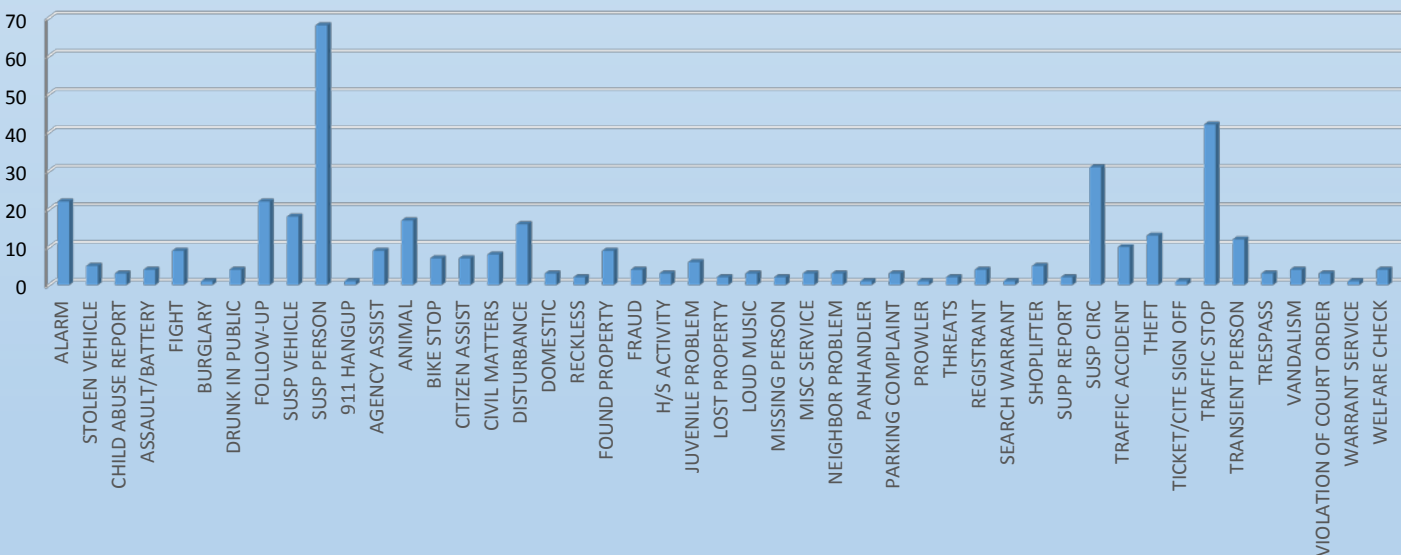

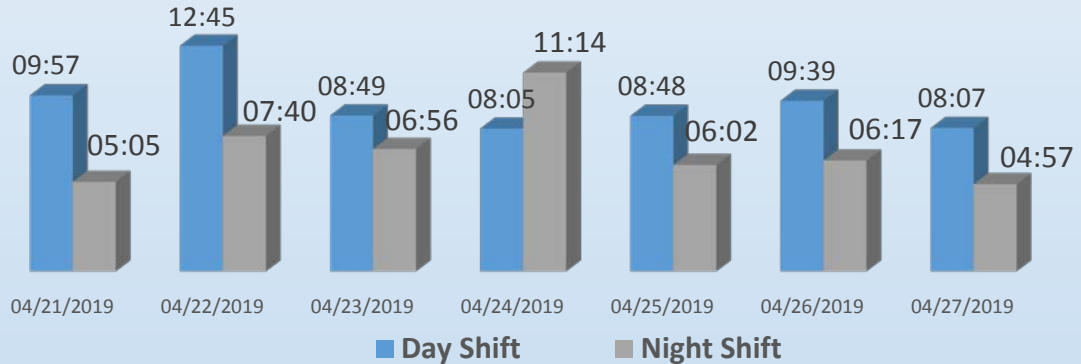

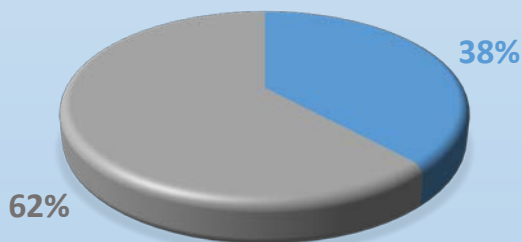
Daily Average Response Times (mm:ss)



The Patrol Division's response time to in-progress calls was just over 3 minutes.

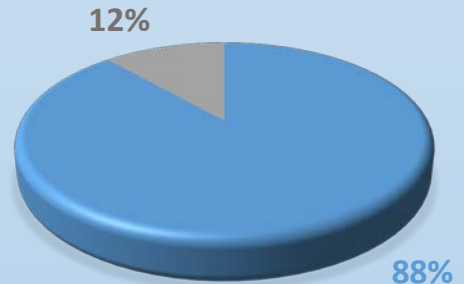
The average response time to all calls was just over 8 minutes.

### CRIME BREAKDOWN



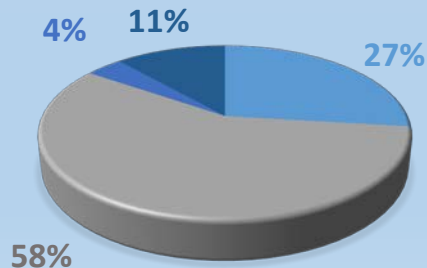

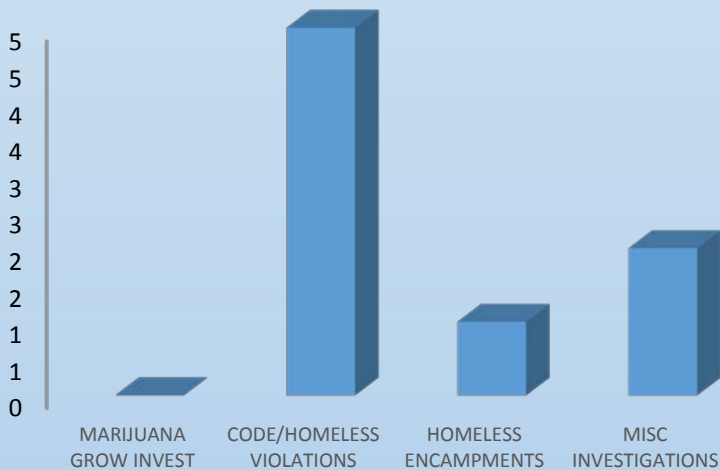

#### UPDATE: 2018 Subway Robbery

##### **SUSPECTS ARRESTED:**

**Dorian Michael Coon (20 year old White male Willits)**  
**Alexander Donovan Romero (19 year old White male Willits)**

On 12/12/18, at 7:18 in the evening, UPD officers were dispatched to Subway, 130 N. Orchard Ave., regarding shots fired at the location. Upon arrival, an officer located a subject with gunshot wounds in front of Ross. The officer provided first aid until paramedics arrived. The subject was subsequently flown to an out of county hospital for medical treatment. It was quickly reported that the injured subject had just robbed the Subway sandwich shop with a firearm. During the robbery, a customer with a valid Concealed Carry Weapons permit discharged his firearm, reportedly in fear for his safety and the safety of other citizens. The customer also was one of the reporting parties to the robbery.

Ukiah Police Detectives responded and took over the investigation. Ukiah Police Detectives processed the scene for evidence, spoke with witnesses and contacted neighboring businesses. The subject who committed the robbery was quickly identified as Dorian Michael Coon. The weapon used by Coon was also located at the scene and found to be a BB gun, that resembled a firearm. Coon subsequently remained out of county for several weeks while receiving medical treatment for his injuries.

Ukiah Police Detectives continued the investigation, interviewing more witnesses and learned of a second suspect who was involved in the robbery. The accomplice was identified as Alexander Donovan Romero. Romero was determined to have assisted Coon immediately prior to the commission of the robbery.

Arrest warrants were sought and obtained for the arrest of Coon and Romero.

On 04/13/19, Romero was booked into the county jail by the Willits Police Department.

On 04/17/19, Ukiah Police Detectives located Coon out of county and placed him under arrest. Coon was transported to the Mendocino County Jail, where he was booked and lodged.

##### **SUSPECTS ARRESTED:**

**Dorian Michael Coon (20 year old White male Willits)**  
**Alexander Donovan Romero (19 year old White male Willits)**

Both Romero and Coon were charged with the following crimes:

209(b)(1) PC—Kidnap for robbery Felony  
236 PC—False imprisonment (two counts) Felony  
211/212.5(c)/213(a)(2) PC—Second degree robbery (two counts) Felony  
272(a)(1) PC—Contributing to the delinquency of a minor (two counts) Misdemeanor

Coon and Romero are both being held on \$450,000.00 bail and the case was forwarded to the Mendocino County District Attorney's Office for prosecution.

#### S. State St. Assault

##### **SUSPECT ARRESTED:**

**Maupin, David Leon (41 years old of Ukiah)**

In the morning of 04-21-19, Officers were dispatched to the area of S. Main St. and E. Gobbi St. for a report of a white Mercedes vehicle that attempted to run over a red haired, White male. The caller reported the vehicle had left the scene. While Officers were responding to the scene, UPD dispatch received numerous calls reporting a red haired, White male had assaulted a female with a large rock at the corner of S. State St. and Gobbi Street. Upon arrival at S. State St. and Gobbi St., Officers contacted a male, who matched the description, and several citizens near the northeast corner of Chase Bank, located at 700 S. State Street. The male was identified as David Leon Maupin, a transient of Ukiah. Maupin was detained without incident while the investigation was conducted.

The subsequent investigation revealed the following:

- An unknown driver of a White Mercedes SUV attempted to strike Maupin with the vehicle, for unknown reasons and then fled the area.
- A female victim (18 years old of Ukiah) was located just west of Chase Bank and she was found to have sustained a significant injury to the backside of her head. She received medical attention from EMS and was released from the scene. She had been crossing State St., was talking on her cellphone and was uninvolved in the prior incident with the vehicle. Maupin came up from behind her and struck her on the back of the head with a nearly 15-pound brick, for an unknown reason. The female victim was not an acquaintance of Maupin and the attack appeared to have been unprovoked.
- While the female victim was lying on the ground, Maupin retrieved another large rock and stood over the victim.
- An elderly male (64-year-old of Ukiah) and his companion were crossing Gobbi St. when he saw the attack on the female victim. This male intervened, in an attempt to prevent further injury to the female victim, by yelling at Maupin. Maupin struck the male victim at least once with a large volcanic rock, knocking the male victim to the ground. The male victim sustained injuries which included a fractured rib and a portion of his ear being torn off. The male victim received medical attention from EMS and was released at the scene.

##### **SUSPECT ARRESTED:**

**Maupin, David Leon (41 years old of Ukiah)**

- Numerous concerned citizens remained at the scene and provided critical information for the investigation. Many of these concerned citizens also rendered first aid for the victims, prior to arrival of Police and EMS.
- Following the investigation, Maupin was placed under arrest for two counts of 245(a)(1) PC ~ Assault with a Deadly Weapon and one count of 203 PC ~ Mayhem. Maupin was found to be on probation for a prior offense of 242 PC ~ Battery.

Maupin was transported and to the Mendocino County Jail where he was booked on the aforementioned violations.

The investigation into the circumstances surrounding the initial report of a vehicle attempting to run into Maupin is still on-going. Anyone with information regarding that incident is urged to contact UPD.

UPD would like to remind residents to be vigilant in being aware of their surroundings and reporting any suspicious behavior or persons. Further, UPD would like to thank the concerned citizens who came to the assistance of victims and Officers.
