

SKATE PARK USAGE DURING SCHOOL HOURS AUTHORIZATION FORM



Children under the age of 18 are not allowed to enter the Skate Park during normal school hours for the 2022/2023 school year without written consent from their parent or legal guardian. It is the parents' responsibility to determine their child's ability to be at the Skate Park during school hours.

All park attendees will be required to follow park Personal Conduct and Behavior guidelines.

The following are prohibited in the park area at all times:

- a. Possession or use of any controlled substance or alcohol;
- b. Being under the influence of any controlled substance or alcohol;
- c. Fighting, aggressive behavior, or other forms of violence;
- d. Abusive, profane, or foul language;
- e. Possession or use of firearms, knives, or other weapons of any kind; and
- f. Smoking or use of tobacco products.

Please Read and Sign Below:

In consideration of the acceptance of my application for entry into the above stated recreation activity(ies), I hereby waive, release, and discharge any and all claims for damages for personal injury or property damage or losses, expenses, including reasonable attorney fees, which I may have or which may hereafter accrue to me, against the City of Ukiah as a result of my participation in the activity(ies). This release is intended to discharge the City of Ukiah, its officers, officials, employees, instructors, agents, and volunteers, from all liability arising out of or connected in any way with my participation in the activity(ies) even though that liability may arise out of the negligence or carelessness on the part of other persons. I further understand that accidents and injuries can arise out of the activity(ies). Knowing the risks, nevertheless, I hereby agree to assume those risks and to release and to hold harmless the City of Ukiah and all of the persons mentioned above who might otherwise be liable to me or my heirs or assigns for damages. It is further understood and agreed that this waiver, release and assumption of risks is to be binding on my heirs and assigns.
