Energy efficiency projects may require city building permits. Prior to beginning work, contact City of Ukiah Community Development Department at 707-463-6203.

## Program Eligibility & Guidelines

- Rebate(s) apply to upgrades on existing buildings only. New construction does not qualify.
- Rebates are based on the Air Conditioning, Heating, & Refrigeration Institute's (AHRI) rated cooling capacity (1 Ton = 12,000 British Thermal Units per Hour (Btuh). The AHRI certificate or AHRI certificate number must be submitted with the application to qualify.
- Installations required by Title 24 codes and standards are not eligible for rebate(s).
- Cubic Feet per Minute (CFM) represents the amount of airflow.
- Seasonal Energy Efficiency Rating (SEER/2), Energy Efficiency Ratio (EER/2), and Integrated Energy Efficiency Ratio (IEER) represent minimum equipment efficiency ratings.
