Energy efficiency projects may require city building permits. Prior to beginning work, contact City of Ukiah Community Development Department at 707-463-6203.

**Program Eligibility & Guidelines**

- Rebate(s) apply to upgrades on existing homes only. New construction does not qualify.
- Duct sealing rebate applies to site-built homes only.
- Installations required by Title 24 codes and standards are not eligible for rebate(s).
- Air conditioning and heat pump rebates are based on the Air Conditioning, Heating & Refrigeration Institute's (AHRI) rated cooling capacity (1 Ton =12,000 Btuh). The AHRI certificate or AHRI certificate number must be submitted with the application to qualify for a rebate.
- Cubic Feet per Minute (CFM) represents the amount of airflow.
- Seasonal Energy Efficiency Rating (SEER), Energy Efficiency Ratio (EER), and Heating Seasonal Performance Factor (HSPF) represent the efficiency ratings.
