

**Resolution 2015-08**  
**A Resolution Establishing Rates, Fees and Charges for the**  
**Millview County Water District**

The Board of Directors of the Millview County Water District hereby resolves as follows:

**Statement of Intent**

This Resolution is adopted pursuant to the authority conferred on the Board of Directors by Article 20 of the District Ordinance establishing Rates, Rules, and Regulations for Water Service by the Millview County Water District.

**Establishment of Rates, Fees, and Charges**

The Board of Directors of the Millview County Water District hereby establishes the following rates, fees, and charges:

**1. Basic delivery charge.** The basic charge for delivery of water shall be as follows;

**2. Water Usage Charges per 1,000 gallons**

Operation & Maintenance	\$1.45	\$1.67	\$1.92

**3. Out of District Service**

Customers located in areas not annexed to the district, but within the districts sphere of influence, shall pay double the district's prevailing water usage rate and double the monthly meter service charge.

#### 4. Temporary Water Service

Except as provided in section 5 below, rates for temporary water service shall be the same as for regular water service; provided however, that if water is delivered or used in an area not annexed to the district, the temporary user shall pay double the district's rate for water delivery and double the prevailing monthly meter charge.

#### 5. Service Connection Charges

A service connection charge shall be imposed on all new services and on all services that are increased in size. The service connection charge shall be equal to the sum of (1) the districts cost of physically installing the service and (2) the capital reserve capacity charge, as follows:

12" and larger shall be calculated using the hydraulic capacity factor of the requested meter size.

#### 6. Other Fees, Charges, Deposits and Penalties

The following additional rates, fees, charges, deposits and penalties shall be collected where appropriate:


