**CITY OF UKIAH NOTICE OF PUBLIC MEETING
FOR DISCUSSION OF POSSIBLE 2025 STATE CDBG APPLICATION**

NOTICE IS HEREBY GIVEN that the City of Ukiah will conduct a public meeting at 4:30 pm, on Wednesday, June 11, 2025 at 300 Seminary Ave, Ukiah, CA 95482 to discuss possible applications for funding under the 2025 State Community Development Block Grant (CDBG) Program and to gather residents' ideas for possible activities to be included in future applications.

The City of Ukiah anticipates submitting an application during the next CDBG program year. California's Department of Housing and Community Development's (HCD) Notice of Funding Availability (NOFA) is scheduled to be released in calendar year 2025. The City of Ukiah has, or anticipates receiving, approximately \$25,000 in CDBG Program Income.

The purpose of this public hearing/meeting is to review CDBG eligible activities and collect residents' views on housing and community development needs such as services, facilities, or infrastructure that will improve livability within the community.

Residents can express their views on housing and community development needs at this public hearing/meeting and at CDBG public hearings/meetings that may be held by the City in the future.

The following information related to the project will be available at 300 Seminary Ave, Ukiah, CA 95482 between the hours of 8:00 am and 5:00 pm, Monday through Friday, or by emailing the contact listed below:

- A. Amount of funds available and range of activities that may be undertaken.
- B. Information on proposed projects.
- C. Estimated amounts of funds proposed to be used for activities benefiting persons of low- and moderate-income.
- D. Plans for minimizing displacement of persons as a result of activities associated with CDBG funds, if any CDBG-funded activities are expected to displace persons. Plans for providing assistance to persons displaced as a result of CDBG-funded activities, if any persons are displaced by CDBG-funded activities.
- E. Records regarding the past use of CDBG funds.
